#### Bangladesh: civil society under attack as dissent is silenced

CIVICUS calls on the Bangladeshi government to stop immediately its campaign of intimidation against civil society activists and to conduct fair and independent investigations into the politically motivated disappearances of activists. Further, the government of Bangladesh should reverse moves to pass legislation that restricts legitimate civil society activities

#### Cambodia: civil society activists defending land rights must not be silenced

Defending land and housing rights in a country marked by illegal land confiscations and forceful evictions of poor communities can be risky business for activists. Civil society activists against forceful eviction of communities from their lands and houses experience repression from the government of Cambodia. In common with others in Cambodia, activists on land and housing rights have over the past four years been faced with new legal restrictions and ferocious retaliation from government authorities for documenting and denouncing abuses.



In his book Sleepwalking into Global Famine, Benny Dembitzer identifies 13 different forces and analyses them and their impact on the worlds capacity to feed its poorest inhabitants.
