

## RATIFICATION DES TRAITÉS INTERNATIONAUX MENTIONNÉS DANS LA DÉCLARATION DU MILLÉNAIRE

**Jusqu'au mois d'août 2010**

**A :** Statut de Rome de la Cour pénale internationale, 1998. Entrée en vigueur le 1er juillet 2002.

**B :** Convention sur l'interdiction de l'emploi, du stockage, de la production et du transfert des mines antipersonnel et sur leur destruction, 1997. Entrée en vigueur le 1er mars 1999.

**C :** Protocole sur l'interdiction ou la limitation de l'emploi des mines, pièges et autres dispositifs, tel qu'il a été modifié le 3 mai 1996, annexé à la Convention sur l'interdiction ou limitation de l'emploi de certaines armes classiques, 1996. Entrée en vigueur le 3 décembre 1998.

**D :** Protocole de Kyoto de la Convention-cadre des Nations unies sur le changement climatique, 1997. Entrée en vigueur le 16 février 2005.

**E :** Protocole facultatif de la Convention relative aux droits de l'enfant concernant l'implication d'enfants dans les conflits armés, 2000. Entrée en vigueur le 12 février 2002.

**F :** Protocole facultatif de la Convention relative aux droits de l'enfant concernant la vente d'enfants, la prostitution des enfants et la pornographie mettant en scène des enfants, 2000. Entrée en vigueur le 18 janvier 2002.

**G :** Convention sur la diversité biologique, 1992. Entrée en vigueur le 29 décembre 1993.

**H :** Convention des Nations Unies sur la lutte contre la désertification dans les pays gravement touchés par la sécheresse et/ou la désertification, en particulier en Afrique, 1994. Entrée en vigueur le 26 décembre 1996.
